Over the past 2 years, Ngā Maunga Whakahii o Kaipara's commercial property company, Whenua Hoko Holdings Ltd ('Whenua Hoko'), has been building strongly, both literally on the ground and metaphorically in the office. As Tumuaki of Whenua

Hoko, I'd like to share some of this mahi and who we are with you.

The whakatauki above reflects the mahi we do, and our approach to business. The currency of the commercial world is information and judgment, and it is critical that we ensure decisions are informed and well grounded. This is particularly so given the responsibility we have to maintain and grow the asset base of Ngā Maunga Whakahii o Kaipara, and because we live in a world of misinformation and a multitude of investment options and pitfalls.

I joined Whenua Hoko as Tumuaki (Chief Executive) in 2016, and have been busy building the business from strategy and execution to building the company's internal resources. Almost 3 years into our investment strategy, I am confident that the property industry will continue to provide a sustainable investment area for the Ngā Maunga Whakahii o Kaipara Development Trust.

Whenua Hoko is involved in the property market, and is part of the commercial investment arm of Ngā Maunga Whakahii. Its business is focused on property acquisition and development, in the rōhe of Ngāti Whātua o Kaipara in Auckland's North-West. Our office is located in Westgate, which we share with some of the Development Trust staff which helps with the business' financial management and operations.

The company's Directors are Grant Hope (Chair), Rhys Freeman, Rob Hutchinson and Chris Caldwell, who collectively bring significant commercial and property expertise to the business. Former Chair, Anita Mazzoleni left the Board earlier this year. I would like to publicly thank and congratulate Anita for her mahi since the settlement in 2013, and on the success she achieved during her tenure.

Whenua Hoko works with its partners to identify opportunities for prudent investment in the local property market. These include Crown agencies (eg MBIE, HLC, NZ Defense Force) and major land developers (eg Fletcher Residential Ltd). We continue to build our internal expertise, resources and infrastructure to increase our ability to deliver strong commercial results and ensure the business remains sustainable and successful. We are working with the wider Ngā Maunga Whakahii group to ensure decisions are informed by relevant non-commercial factors and wider objectives and values of the Group.

Te Awaroa Town Centre Upgrade

The North West Country Business Association, through member Geraldine Bayly, a landscape architect from Kaukapakapa, has been working with NZTA and Council to prepare plans for a town centre upgrade in Te Awaroa - Helensville.

This follows meetings with Business Owners, Commercial Building Owners



and a Community Survey held outside Countdown earlier in the year. People highlighted the importance of the Awa and the lack of links to it from the main street. The ideas will utilise this feedback.

Detailed plans will be completed soon so construction can start this financial year. Once these plans are available we will post a link to them.

Kaiarahi Caring for Papatūanuku

It is exciting to welcome Tumanako Povey and Hemi Tapurau as Kaiarahi with Nga Maunga Whakahii o Kaipara Development Trust. Their primary role is looking after land that was returned at Settlement to Te Tari Pupuritaonga Trust for future generations.

Both Hemi and Tumanako are passionate about our whenua. Hemi has spent many years trapping pests on Atuanui, protecting trees, birds and insects from predators. Hemi's dream is that one day Kiwi walk there again.

Atuanui, the largest block of land returned, 625 hectare, is home to many Kauri. It is especially important at this time that we protect them from the risks of Kauri Dieback.

Tumanako has spent time as Kaitiaki at Te Ngahere as well as working in the past in the Waitakere Ranges. He has had first-hand experience of the devastating loss there.

We have other land that will benefit from their knowledge and nuture. We look forward to sharing more about their mahi and the opportunities for others to reconnect with their whenua.
