In a moving ceremony lead by Te Kura Kapea and attended by Whanau, Rodney Local Board Chair, Representatives from Department of Conservation and Auckland Council. The whenua was closed to reduce the risk from Kauri Dieback and was followed by hakiri at Puatahi Marae who whaka-Kauri Dieback disease is



ried further by water, at this point there is no cure. We ask everyone to respect the Rahui so that Atuanui can remain strong. 15-23 September marks conservation week in Aotearoa. Some of our whanau will be visiting Papakanui Spit on Thursday 20 September in recognition. Matua Greg Smith will lead the hikoi and share korero about the area and it's history.

Te Tari Taiao has presented the final report of a Two-year study by Massey University Honurs student Meredith Davis on stream quality from selected waterways in the Kaipara. The report can be found on our website or can be requested from the office.

HAVE YOUR SAY! Review of Trust Deed

Here's your chance to have a say about how things are going for Ngāti Whātua o Kaipara.

The trust deed of Ngā Maunga Whakahii o Kaipara Development Trust ("the Development Trust") requires the trustees to review "the terms and operations" of the trust deed within four years of settlement. This review process has just started.

The trust deed can be a daunting document to read—it runs to more than 70 pages. You don't have to be completely familiar with the document to participate in this review. You only need to be able to answer questions like these:

- do you believe the activities of the Development Trust are moving us towards the kind of future you want for Ngāti Whātua o Kaipara? Why?
- does the current organisational structure, comprising the Development Trust and a series of subsidiaries, still work well for us? What changes would you make to this structure?
- do you think the Development Trust and its trustees are sufficiently accountable to the iwi? What would you change to improve accountability?
- are you happy with the number of trustees and the way they are chosen ? If not, what changes would you make to the electoral system?
- are you satisfied with the role and functions of the Nohoanga Kaumātua?
- are you satisfied with the process to become a registered member of Ngāti Whātua o Kaipara?

These questions are just examples-you can comment on any aspect of the post-settlement structure and operations.

The trust deed requires the review process to be independently facilitated. The Development Trust has appointed David Gray of Kia Tū Rangatira Ai Consulting. David's job is to gather the views of Ngāti Whātua o Kaipara, draw out the common themes from these views, and make recommendations to the Development Trust for how things might be improved.

David will attend hui at each of the marae over the next couple of months, meet with the trustees of the Development Trust and subsidiaries, meet with staff, attend at least one Turanga Kaumatua hui, and attend the Annual General Meeting in September. He is available to meet with individuals or groups from the iwi at a time and place to suit you. Submissions can be made either verbally or in writing. The review process is completely confidential—nothing you say to David will be made public. Any ideas or suggestions that are included in David's final report to the Development Trust will be kept anonymous. It's really important for the generations of Ngāi Whātua o Kaipara to come that we get our post-settlement structures and operations right. Now is the time to have your say on how we're doing in this regard and what, if anything, needs improving.

- Learn your pepeha, it is a way to understand the connections our different Marae have to each other.
- Find a mate, cousin, friend, and commit to practice your reo. Everyone has to start somewhere. You dont have to be flash, or fancv.
